### **Robert J. Sullivan Fund Announces \$9,000 Grant Cycle**

**Sayre, PA.** –The Community Foundation for the Twin Tiers (CFTT) is currently accepting grant applications for the Robert J. Sullivan Fund, a competitive grant-making program funded through the legacy of Robert J. Sullivan a former resident and businessman from Bradford County, PA.

The Robert J. Sullivan Fund, one of several grant programs administered at CFTT, is to strengthen communities and improve the quality of life in Bradford County through assisting local non-profits attain their missions. There is \$9,000 available to grant.
